

ORDINANCE NO. 275

1 AN ORDINANCE CONCERNING NOISE, ODOR, AND SAFETY AND ESTAB-
2 LISHING REGULATIONS FOR TRUCK PARKING IN THE CORPORATE
3 LIMITS OF THE TOWN OF BROADUS, PROVIDING ENFORCEMENT PROVI-
4 SIONS THEREFORE AND ESTABLISHING PENALTIES FOR VIOLATIONS.

6 The Town Council of the Town of Broadus, Montana does
7 ordain as follows;

8 SECTION ONE - APPLICATION

9 This Ordinance shall regulate the parking of trucks,
10 truck trailers, semitrailers, horse trailers and homemade
11 trailers.

12 SECTION TWO - NOISE

13 It shall be unlawful to park any truck or truck
14 trailer loaded with live cattle, sheep, swine, poultry or
15 other animals within 300 feet of any residence house in the
16 corporate limits of the Town of Broadus between the hours
17 of 10:00 P.M. and 7:00 A.M.

18 It shall be unlawful for any truck to be parked with
19 the motor left running within 300 feet of any residence
20 house in the corporate limits of the Town of Broadus
21 between the hours of 10:00 P.M. and 7:00 A.M.

22 SECTION THREE - ODOR

23 It shall be unlawful to park any trucks used to haul
24 pigs, livestock, manure, fertilizer, furs, carcasses, or
25 other substances which emit a decerable offensive odor
26 within 300 feet of any residence house or business estab-
27 lishment in the Town of Broadus for more than one (1) hour.

28 SECTION FOUR - SAFETY

29 It shall be unlawful to park any trucks hauling
30 radioactive wastes or materials, or explosives within the
31 corporate limits of the Town of Broadus.

32 No truck shall at any time park where it blocks access

1 to a fire hydrant, driveway, garage, private home or
2 public business.

3 SECTION FIVE - EXCEPTIONS

4 Sections One, Two and Three shall not apply to stops
5 required for fuel, repairs, meals or bona fide emergencies.

6 Section Three shall not apply to trucks used for the
7 local delivery of fuel such as oil, gasoline, and propane.

8 Section Two shall not apply to livestock hauling
9 vehicles properly parked in designated areas at county
10 fairs, rodeos, ropings, agricultural shows, livestock
11 auctions, and similar agricultural events.

12 SECTION SIX - PENALTY

13 Any person, agency, corporation, or business entity
14 guilty of violation of this Ordinance shall be fined an
15 amount up to One hundred Dollars (\$100) for each offense.

16 SECTION SEVEN - EFFECTIVE DATE

17 This Ordinance shall be effective immediately upon its
18 passage and approval.

19 SECTION EIGHT - SEVERABILITY

20 If any provision of this Ordinance or application
21 thereof to any person or circumstances is held invalid,
22 such invalidity will not affect other provisions or
23 applications of this Ordinance which can be given effect
24 without the invalid provision or provisions, and to that
25 end the provisions therefore declared to be severable.
